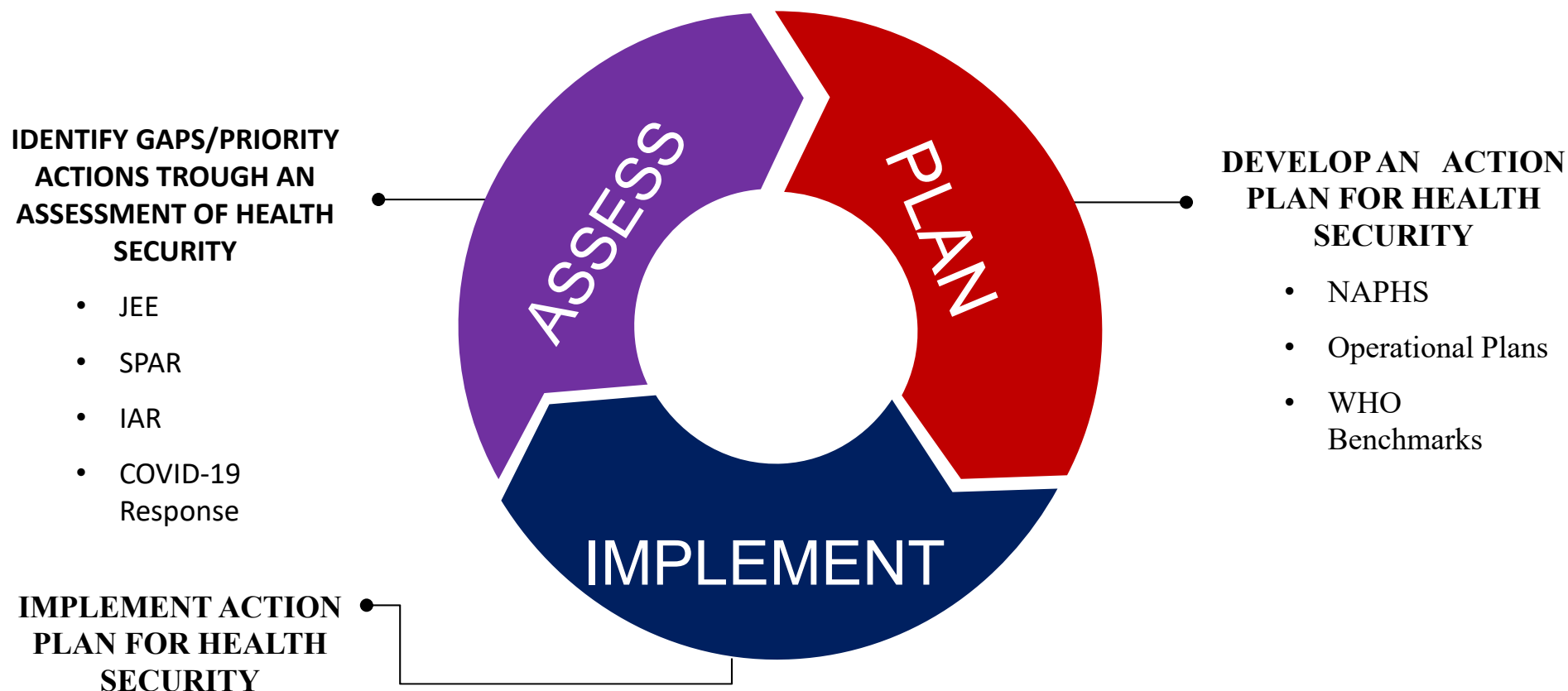

Joint External Evaluation

- Transparent independent, and objective assessment of a country's capacity to prevent, detect, and respond to public health threats



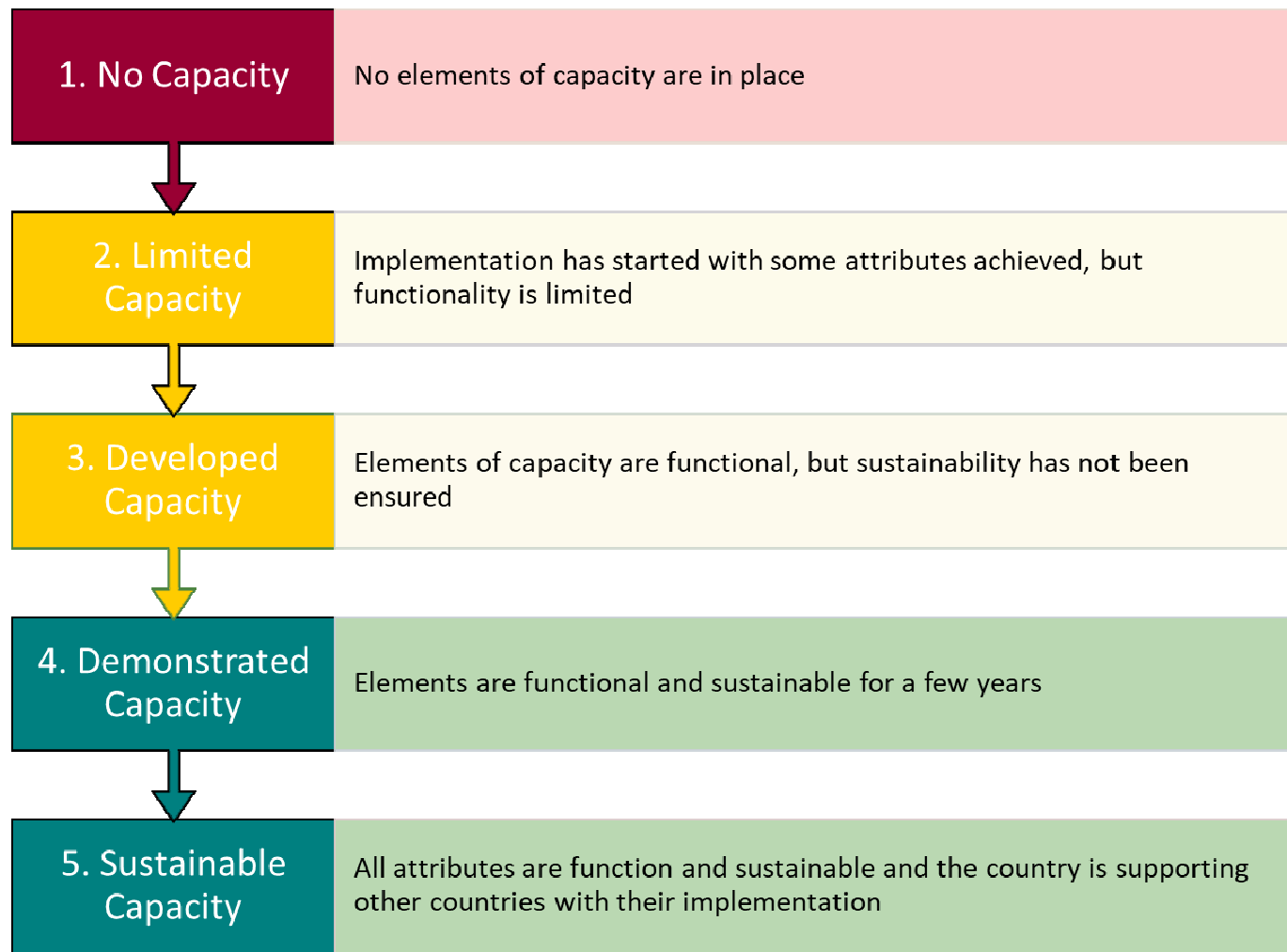
Joint External Evaluation

- Data gathering instrument created to evaluate a country's capacities for health security at a national level across all sectors
- Designed to examine country-specific capacity across 19 technical areas
- Combines qualitative and quantitative measures

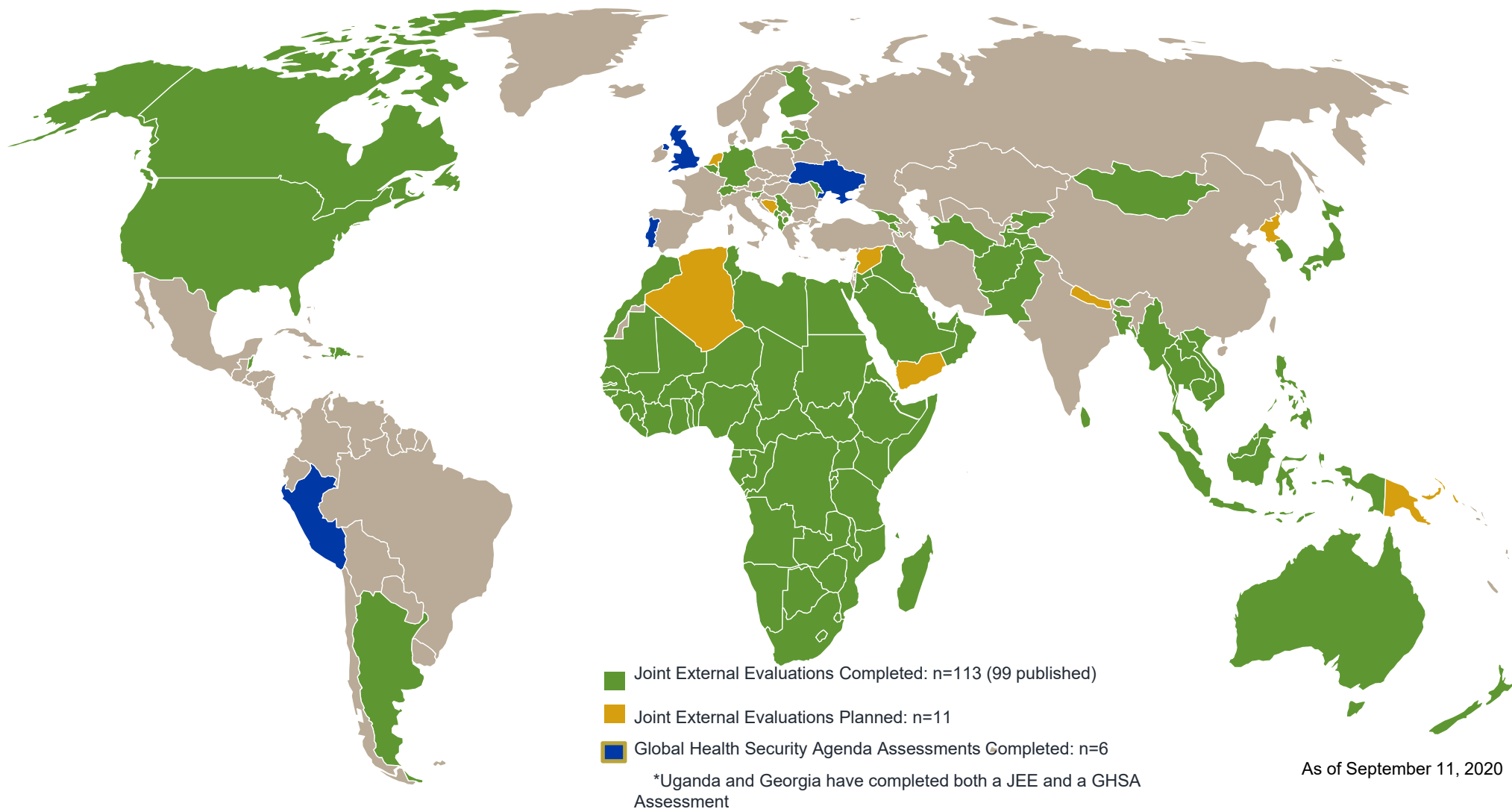

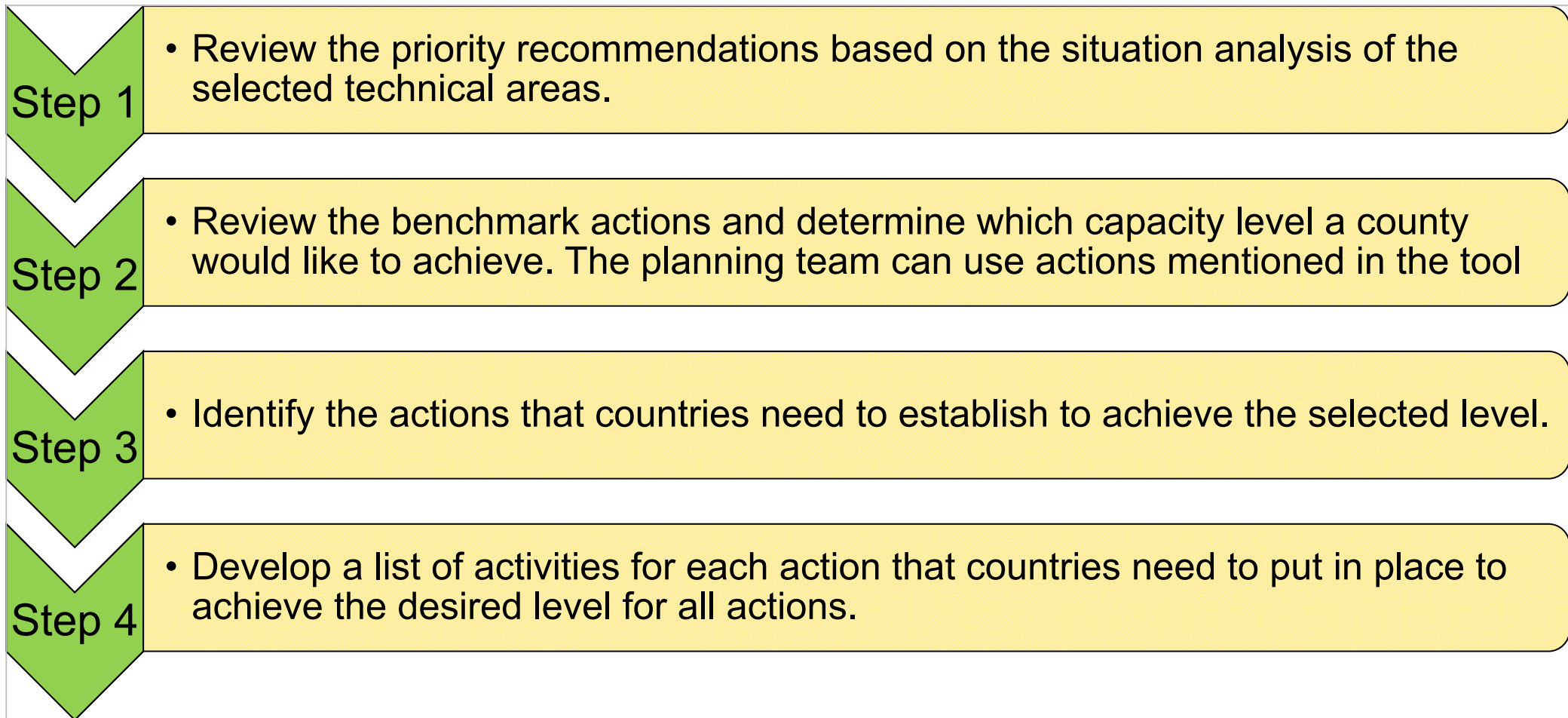

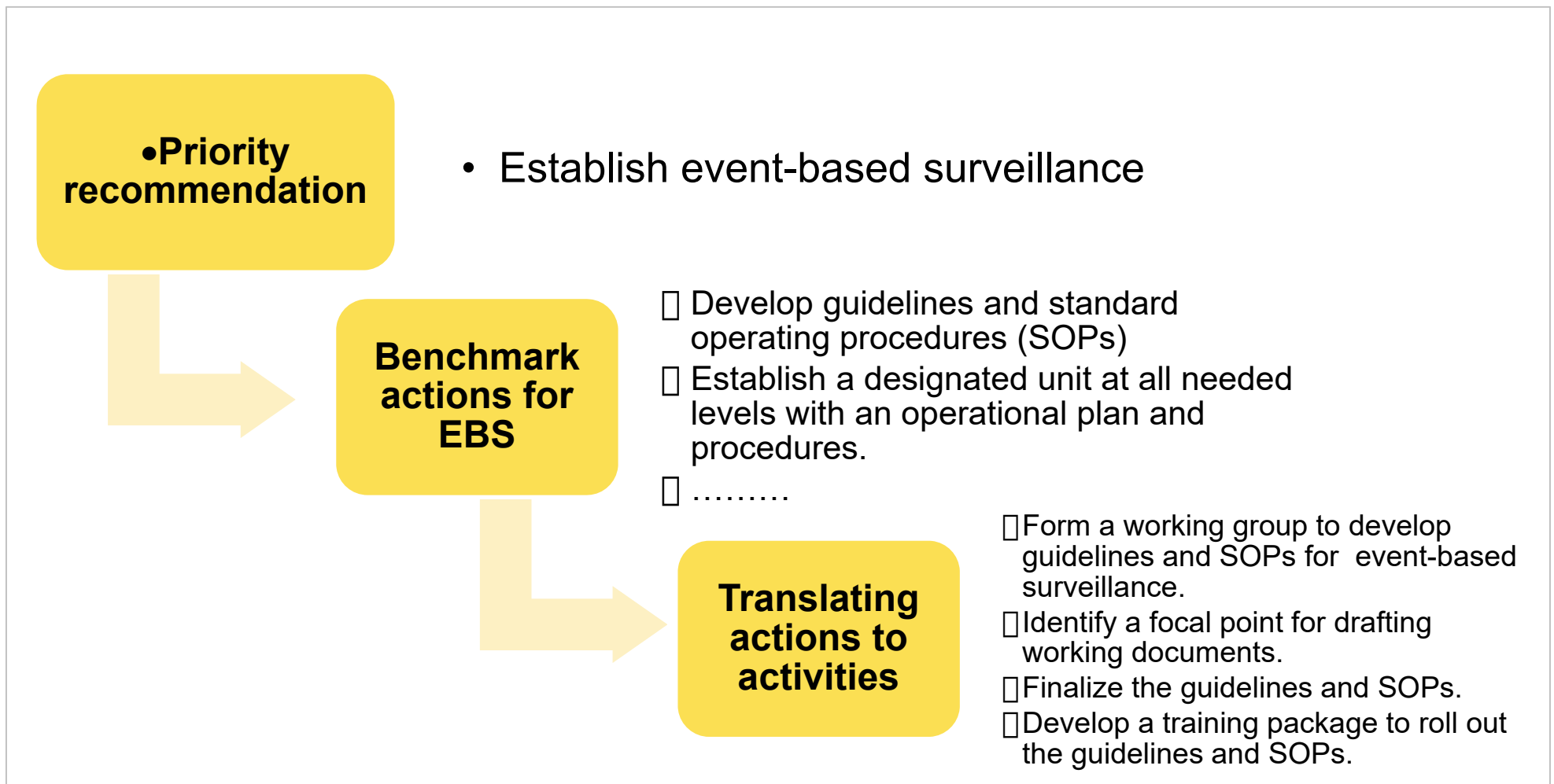
